In accordance with New York State Education Law, a Transportation Request Form for transportation to a nonpublic school must be submitted for eligible students no later than **April 1, 2022**. Returning students may mail or fax their completed Transportation Request Form (enclosed) to:

New registrants and currently registered students who have moved are required to file online or in person at the Office of Registration, located at 124 Grand Street, Newburgh, between the hours of 8:00 AM and 3:30 PM and provide the following:

- Birth Certificate (In accordance with New York State Education Law student must be 5 years of age prior to December 1, 2022 to be eligible for transportation)
- Picture ID of parent/guardian
- Immunization record and recent Physical Examination
- Proof of residency (utility bill, rental agreement or mortgage statement)

If the student requires an alternate /babysitter stop, an Alternate Stop Form must be completed and returned before April 1st as well. Forms are available on the transportation page of the District website [www.newburghschools.org](http://www.newburghschools.org) or at the Transportation Department.

Parents/guardians are reminded that signed applications must be received by the Transportation Office no later than April 1, 2022 for a student to be eligible for bus transportation in September 2022. **Late requests will result in your child(ren) being assigned to a group pick up and drop off location.**
